Stuck in Prison, he asked wife to marry someone else

Hyderabad/ August 11

Kaleem, who had a love marriage with Aiysha (name changed) just two months prior to his arrest in 2005 in the Task Force bomb blast case, is a distraught man. His family life came to naught, being in jail for the past 12 years. Realising that he was stuck in jail when he became an undertrial, Kaleem told his wife of five years to remarry. The couple hadn't been able to spend much time even during their initial days at his mother's place, Kaleem's cousin Aslam told TOI. Now, Aiysha is married to someone else. Kaleem was just 23-years-old when he was held. Now 35, Kaleem, a welder by profession and a resident of Amberpet, was picked up by Task Force sleuths when he and his family were on their way to Hyderabad. "Their vehicle was intercepted and policemen took him away. We did not understand why Kaleem was taken away until two days later when he was announced to have been arrested in the Task Force blast case," one relative said. According to them, the allegation was that Kaleem went to Bangladesh and conspired with other members of Harkat-ul-Jihad-al-Islami before returning to Hyderabad along with Dalin, a Bangladeshi national who executed the blast. Kaleem was allegedly tortured in police custody to the extent that he cannot walk properly.
